In the University Notification bearing No.Aca.III:A3:Affl.Fee Structure: 2025-26 dated 24.10.2024 cited at ref. 2, the following correction to the said Notification is carried out:

As per the Notification (Third Para):

“Further, GST @ 18% is applicable to all the affiliation fees prescribed as per the clarification by the Joint Secretary, TRU-II, Ministry of Finance, Govt. of India in the circular dated: 11.10.2024 cited at reference 3 above. However, the clarification to levy GST @ 18% on the affiliation services provided by the Universities to its constituent colleges is subject to the appeal application filed by Bangalore University and writ petition filed by other Universities in the Hon'ble High Court of Karnataka.”.

To Read as:

“Further, GST @ 18% is applicable to all the affiliation fees prescribed as per the clarification by the Joint Secretary, TRU-II, Ministry of Finance, Govt. of India in the circular dated: 11.10.2024 cited at reference 3 above. However, the clarification to levy GST @ 18% on the affiliation services provided by the Universities to its constituent colleges is without prejudice to the appeal application filed by Bangalore University and writ petition filed by other Universities in the Hon'ble High Court of Karnataka.”

Consequentially the correction were carried out to the Note No.2 of the Annexures to the notification cited at reference 2.

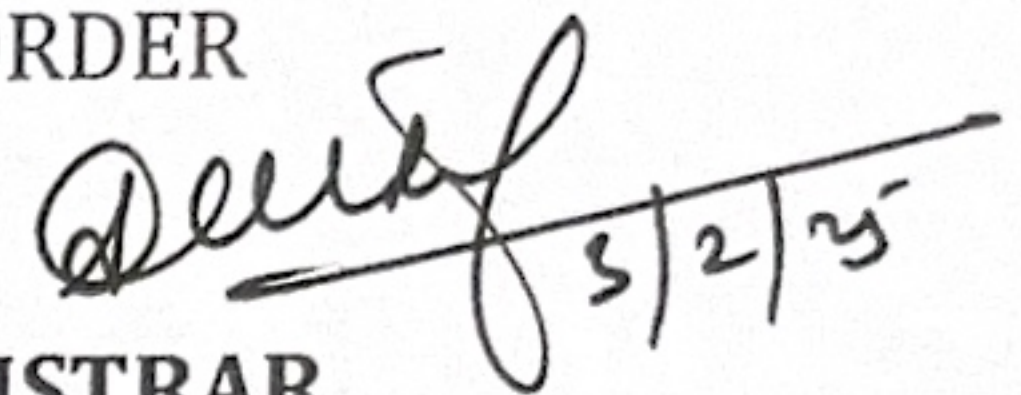
Note No.2 To Read as:
